Urgent Notice
Temporary Traffic Regulation Order 2024
Section 14(2) of the Road Traffic Regulation Act 1984

Downham Market (WTRO5092b) Notice

In accordance with the provisions of Section 14(2) of the Road Traffic Regulation Act 1984, the Norfolk County Council HEREBY GIVE NOTICE that owing to stud replacement works the use by vehicles (of any class/specific class) of the A10 Lynn Road Eastern Bypass from its junction with A1122 Downham Market Southern Bypass to its junction with Bexwell Roundabout (the "Road") in the Town of Downham Market will be temporarily prohibited/restricted.

The closure/restriction is necessary or expedient because works are being or are proposed to be executed on or near the Road.

The closure/restriction is anticipated to take place from 8th to 10th July 2024 only whilst signs indicating closures are in place but the Road may continue to be closed/restricted until the 12th July 2024 where the closure/restriction is still required beyond the anticipated dates.

This Notice shall be in effect from 8th to 12th July 2024 or until the closure/restriction no longer necessary, whichever is the earliest.

This Notice shall automatically revoke on the completion of the works when the closure/restriction is no longer necessary or otherwise on the 12th July 2024 without further notice.

If necessary, this Notice may be extended for a maximum of 18 months from the date this Notice is effective by an Order.

Alternative route is via: A10, Lynn Road, Main Road, West Winch Road, A47, Elm High Road, Outwell Road, Wisbech Road, Downham Road, Nordelph, Lady Drove, Bridge Road, Station Road, A1122 (Watlington, Downham West, Tilney All Saints, Stow Bardolph, Nordelph, Terrington St. John Walsoken Downham Market, Walpole Highway, North Runcton , Elm , Emneth , Wimbotsham, West Walton, Ryston, West Winch, Tilney St. Lawrence, Outwell, Tottenhill, Runcton Holme).

A person who contravenes, or who uses or permits the use of a vehicle in contravention of the restriction/ closure imposed by the Order shall be guilty of an offence.

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
